The UBAS Act

UBAS Act, Subsection 7(1)

- “...the **owner** of each building in Saskatchewan shall ensure that the building is designed, constructed, erected, placed, altered, repaired, renovated, demolished, relocated, removed, used or occupied in accordance with the building standards.”

The UBAS Act

UBAS Act, Subsection 10(1)

- “...the **owner** of each building in Saskatchewan shall ensure that the building meets the accessibility standards.”

The UBAS Act

UBAS Act, Subsection 4(1)

- “...each **local authority** shall administer and enforce this Act, the regulations and orders and decisions of the appeal board...”

The UBAS Act

UBAS Regulations, Subsection 3(2)

- “No **person** who is required to comply with the Act and these regulations shall fail to comply with the Code.”

The UBAS Act

UBAS Act, Section 3

- “The **Crown** is bound by this Act.”

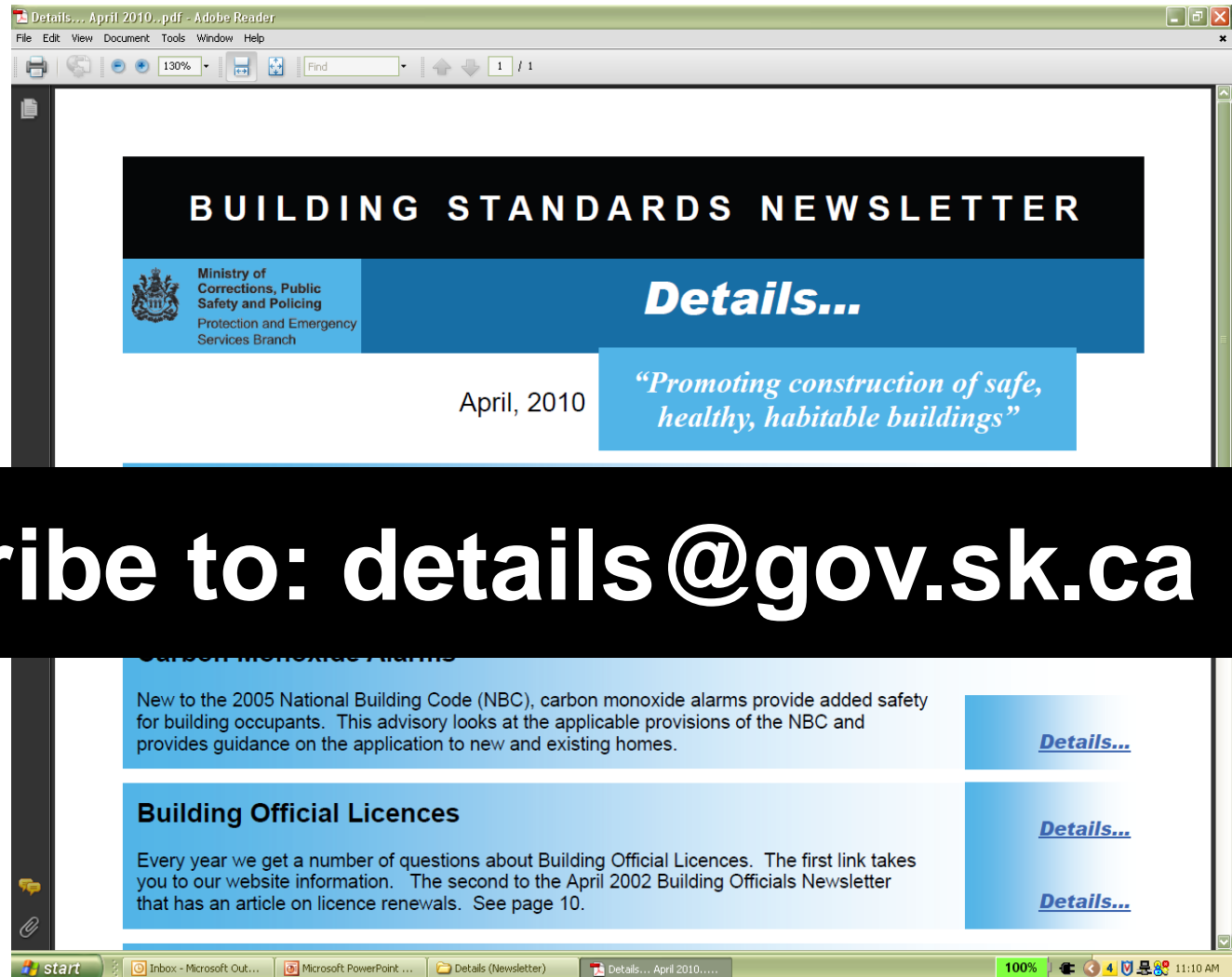
