- Recommendations - final part of report
- Is road network serving purpose within the region
- Population - # active people within area

Russ:

- We've been meeting with Stu Warner of Munisoft
- Highways have indicated that they will share info
- GIS - assess value of each road - background

Fred Baran:

- Formal report (20 pages)
  - Fairly short
  - Recommendations
  - Conclusion - direction
- Watershed info is useable - background - their recommendations

Russ: Do we lay out 20 year plan? Milestones?

Fred Baran:

- No - Sustainability rather than long range goals
- Plan should be a 'living document' that is always changed
- You build it into report - meet once a year - review whole plan in 10 years

- Zones - intent to permit/accommodate/prohibit

- When done? Do we want to present this to government? Are we looking for money?
- Provincial atlas - gas and oil deposits
- Depth of plan is up to committee and stakeholders
- Plan is being done based on needs of people - other objectives become secondary (wildlife)
  
- List concerns from 1<sup>st</sup> round of public meetings at second round of public meetings so that stakeholders can see their issues being addressed
- Wouldn't need all background information before starting public meetings
- When you get local buy-in - government won't contradict plan
- Tourism/Recreation - key objective?
- How do you start a plan to change zoning that was put in place by provincial government?

  - John Nillson - SERM
- Do we presume that there is no plan? Present our own?
  
- Boundaries - Stay with whole municipalities:
  - 314, 315, 345, 284, 285, 254, 255

- RM o either side of river, Beaver Creek down to Danielson Park
- Limit areas to South but not necessarily to either side

**GOAL:**

To manage the area with a view to long term sustainability, conserving distinctive features and optimizing the area's economic, social and cultural opportunities and benefits.

**OBJECTIVES:**

- 1) Create zones with the intent to permit, accommodate and prohibit.
- 2) Manage land use in concert with provincial departments, to address issues of wetlands, surface and sub-surface water, and irrigation opportunity.
- 3) Develop a land use plan that addresses:
  - a. Tourism and recreation.
  - b. Private development land use activities.
  - c. Public preserves.
- 4) Include specific identified protection for wildlife management, protecting diversity and habitat.
- 5) Provide zoning for intensive agriculture.
- 6) Zone taking air quality into consideration.
- 7) Include guidelines for sand and gravel development complete with reclamation plan.
- 8) Include guidelines and policy for gas and oil exploration.
- 9) Identify map and protect archeological, heritage and cultural sites.
- 10) Address issues around range management.
